NATURE OF EXHIBITS: Exhibits during NCPE seminars are intended to provide a showcase of products and services, either specifically designed for or customarily used in the accounting and tax fields. PASC reserves the right to refuse to rent space to any company whose display of goods or services is not, in the opinion of the PASC Board, likely to be compatible with the general character and objectives of the exhibit.

SUBLETTING OF EXHIBIT & PROHIBITED USES: Exhibitors are prohibited from assigning or subletting any part of the space allotted to them, nor shall they exhibit or permit to be exhibited in their space any merchandise or advertising materials which are not a part of their own regular products, or which are not compatible with the character of the seminar.

SELLING OF PRODUCTS: PASC provides display space for suppliers to exhibit and demonstrate on the basis of their potential information and commercial value. Exhibitors will be required to adhere to such rules and regulations as may be established by the Colorado Department of Revenue relating to taxation.

PAYMENT AND PROVISION IN CASE OF DEFAULT: If an exhibitor fails to pay when due any sum required by the Contract, or fails to perform any other term or condition of the Contract, or fails to observe and abide by these Contract Conditions/Rules and Regulations, PASC reserves the right to terminate the Contract immediately without refund of any monies paid.

CANCELLATION OF CONTRACT: Notice of cancellation of exhibit space must be in writing to the Public Accountants Society of Colorado, PO Box 1078 Eastlake, CO 80614-1078. Refunds will be given only for cancellations received two weeks prior to the event date.

INSURANCE AND LIABILITY: Neither PASC, its members or officers nor the hotel representatives or employees where exhibit is located will be responsible for any injury, damage, or loss that may occur to the exhibitor or the exhibitor's employees or property from any cause whatsoever, prior during or subsequent to the period covered by the exhibitor contract. The exhibitor, by signing the Contract, thereby assumes such risk and expressly releases the above-named parties from all claims for any such loss, damage or injury. It is recommended that exhibitors obtain adequate insurance coverage at their own expense for property loss or damage and liability for personal injury.
